### **Deal Midas Privacy Notice**

Private Equity Technologies, Inc. dba Deal Midas ("Deal Midas", "we" or "our") understands that you are concerned about privacy, so we've provided this privacy notice (the "Privacy Notice") to disclose how we collect, use, share, and store your information. This Privacy Notice applies to the Deal Midas website (currently located at https://dealmidas.com) and the related downloadable or web applications and services offered by Deal Midas ("Services") and email, text, or other electronic messages between you and Deal Midas. It does not apply to information collected by us offline or through any other means; or any third party including through any application or content (including advertising) that may link to or be accessible from or on our website or Services.

Please read this Privacy Notice carefully to understand our policies and practices regarding your information and how we will treat it. If you do not agree with our policies and practices, your choice is not to use our website or our Services. By accessing or using our website or Services, you agree to this Privacy Notice. This Privacy Notice may change from time to time and your continued use of our website or the Services after we make changes is deemed to be acceptance of those changes, so please check the Privacy Notice periodically for updates.

### **Information We Collect**

When you visit the Deal Midas website, we collect any contact information that you voluntarily provide to us on our Contact Us page, including your name and email address. If you express interest in our Services, purchase our Services, or become an authorized user of our Services, we will collect your contact information including your name, company name, address, email address, and phone number. When you purchase our Services, we will collect additional billing information including billing name and address, credit card number, and the number of employees within the organization that will be using the Services. If you apply for a job with Deal Midas, we may require you to provide additional information including a resume. We also collect the personally identifiable information that you choose to enter into the Services in connection with your use of the Services functionality ("Customer Data"). Through our Link Midas feature, we collect for your use links to company websites or professional and personal profiles that match the contact information of the Customer Data that you voluntarily enter into the Services. We also collect any other personally identifiable information that you voluntarily provide to us when you communicate with Deal Midas including personal correspondence such as emails or any other activity through which you identify yourself. To the extent we are able to do so, we may link your non-personally identifiable information with your personally identifiable information. We may also link information collected online with information we collect offline or information collected online by third parties.

While you browse our website, we may collect information, that by itself typically cannot be used to identify or contact you, through the use of cookies or other now known or later developed technologies to assist Deal Midas in observing the behavior of users visiting our website or using our Services. Such information may include your web browser type and browser language, your internet protocol address, and navigational actions you may take on our website or our Services such as which pages you view and which links you click. These technologies access individual user information but the information is used only to compile aggregated statistics about our website's or our Services' usage. We will not know who you are unless you arrived at our website through an email link we sent to you or you login to the Services while you are on our website.

When you download, install, or use our mobile application or Outlook add-in application, the application may collect information about your use of the application, including information you provide directly or through automated means (including, for example, cookies), such as geolocation (only if you choose to share it), application usage, device and operating system identification, and login credentials.

## **Cookies**

A cookie is a small file placed on the hard drive of your computer. You may refuse to accept browser cookies by activating the appropriate setting on your browser. However, if you select this setting you may be unable to access certain parts of our website or Services. Unless you have adjusted your browser setting so that it will refuse cookies, our system will issue cookies when you direct your browser to our website.

## Third-Party Use of Cookies and Other Tracking Technologies

Deal Midas may use the information collected from you:

- to process payments for the Services that you have purchased from us;

Deal Midas will not review, share, distribute, or reference any Customer Data except as provided in the application agreement for the relevant Services, as may be required by law, or in the form of aggregated demographic and statistical information that is not personally identifiable (see Sharing Your Information below). Deal Midas will access Customer Data only for the purpose of providing the Services or preventing or addressing service or technical problems or as may be required by law.

You can opt-out of receiving marketing and promotional emails from Deal Midas at any time by selecting the opt-out link included in the email or by responding by email that you no longer wish to be contacted for advertising or promotional purposes (as applicable). Although we strive to update our email list as frequently as possible, you might receive another contact before we are able to remove you. Please note that even if you opt-out of receiving

During the course of our business we may also share with third parties aggregated demographic and statistical information (including that derived from Customer Data) that is not personally identifiable.

- if, in the reasonable judgment of Deal Midas, it is necessary enforce compliance with our internal policies or the agreement for our Services; in a lawful attempt to collect a debt owed by you; or to protect our website, Services, customers, or others;
- to an agent used by Deal Midas to evaluate the individual's creditworthiness or to collect the individual's or company account;
- to a credit reporting agency;
- in situations where sharing or disclosing your information is required in order to offer you Services you have purchased or provide you with information that you have requested;
- in connection with a legal action or other proceeding, including without limitation, in response to a court order or a subpoena;
- in response to a law enforcement agency's request;
- to another entity as part of a merger, bankruptcy, a sale of assets or all or part of a business, or any other corporate change or re-organization; or

• to a third party or parties, where the individual consents to such disclosure or disclosure is required or permitted by law.
